Plans must contain the following minimum contents. This list is not intended to be all inclusive of every detail required. It does provide an overview of the basic plan contents.

Site Plan

Property lines and any existing structures, note existing windows (W) and doors (D)

Dimension and location of new pool and/or spa including all amenities such as water features, diving boards, slides, hand holds, ladders, stairs, deck seats, lighting

Location, size and type/material of all gas piping including BTU's of appliances served

Pool barrier location & construction details

Location of pool equipment

Construction Plans/Engineering

Must be sealed and signed by a Arizona civil or structural engineer

Electrical Load Calculations

Required when installing heat pump
